



LAST QUARTER ACTIVITIES (JANUARY - MARCH 2024)





SAVE A LIFE NALOXONE TRAINING DAY WITH LOCAL HEALTH DEPARTMENTS/DISTRICTS

In honor of National Public Health Week (April 1 – 7) we participated in a statewide Naloxone training day on April 2nd. There were 13 additional health departments/districts across the state that offered Naloxone training that day or during the week including:

Overdose Emergency Kit Wall Cabinet and Signage:

In an effort to increase access to naloxone in Meriden, in 2023 we started distributing overdose emergency kit wall cabinets and signage. These are branded with our contact info and QR code to our harm reduction webpage.


Thirty branded wall kits with signage have been distributed thus far in the Meriden community!

Medication Drop Box: Have unwanted or expired medication in your home? Take it to the drop box in the lobby of the Meriden Police Department located at 50 West Main Street! It is available



Medication Disposal Bags: Can't make it to the drop box? We offer Deterra medication disposal bags and Dispose RX packets to residents.

The Deterra bags or Dispose RX packets are easy and environmental friendly ways to dispose of unwanted or expired medications. Each Deterra bag will hold 45 pills, 6 oz. of liquid, or 6 patches. The Dispose RX packets can be used directly in pill vials from the pharmacy!

Call (203) 630-4221 to request a medication disposal bag or packet. Deterra bags and Dispose RX packets are also given out at community events we attend.
